## **Towing Warning**

Please take note that cars with expired license plates or expired registration or NO plates, or flat tires will be towed from the North Crossing community. <u>Cars can also be towed from your driveway</u> if they have expired or no plates. <u>DOUBLE PARKING</u>: if you need to run into your home for a second or drop someone off you must leave your car running & hazard lights ON to avoid being towed. Do not ever leave your car double parked behind other vehicles; even if it is your own. Should your car be towed, please contact Grimm's Towing to retrieve it. They are located at 502 N. # **Pool Pass Procedure**

## Save these instructions to ensure you register for pool passes prior to the deadline.

**POOL HOURS:** The pool will open May 29 at 10:00a.m. *Pool hours will be: M-F 12-8pm; Fri, Sat-Sun, Holidays 10-8pm. When school is in session, the M-F hours will be 4-8pm.* 

#### WHEN TO REGISTER: Register for passes April 1-April 30.

**HOW TO REGISTER:** Register on the community site, <u>www.northcrossing.org</u>. If you don't already have one, you must first request a user name and password.

**WHO CAN REGISTER:** Only accounts with a \$0 balance may register for passes. DO NOT register if you have a balance. Your registration will not go through and you will have to resubmit the form after you've paid your annual assessment. You will not be notified of the failed registration, so please ensure you have a \$0 balance.

**HOW MANY POOL PASSES PER HOUSEHOLD:** Same as last year, passes will be issued either for an Adult or Child (not by name). A child is considered 12 years and younger. Each household may have up to a **total of 7** passes (that is any combination of adult and children for a TOTAL of 7).

**WILL I GET A GUEST PASS:** Households registering prior to the April 30 deadline will receive a 1-time guest pass. All registrations AFTER April 30 will NOT receive a guest pass. Additional guest passes may be purchased at Clagett Management for \$20.00. Clagett can accept a check only (no cash or credit cards). Checks must be payable to North Crossing HOA.

**HOW WILL I GET MY PASSES:** All registrations received prior to opening weekend will be available for pick-up, at the pool opening weekend (May 28). BRING ID ON YOUR FIRST VISIT WHEN YOU ARE PICKING UP YOUR PASSES.

**FOR LATE REGISTRATIONS, HOW WILL I GET MY PASSES:** For registrations received after opening weekend, passes must be picked up at Clagett Management, 7540 N. Market Street. Please allow five (5) days for processing after registering. BRING ID WHEN YOU ARE PICKING UP YOUR PASSES.

**CAN MY GUESTS USE THE POOL WITHOUT ME:** Guests must be accompanied by a registered member to use the pool and they must remain with their guests for the duration of their visit.

**TENANTS CAN REGISTER:** Tenants can register if you are certain the HOA account has a \$0 balance. Please ask the owner prior to registering. Registrations will not go through if there is a balance on the account.

**LOST POOL PASSES:** You may contact your Association Manager, at Clagett Management, to request a replacement for a lost pool pass. The cost is \$5.00 per card.
